 The School shall also ensure the compliances with the Board's Bye-laws in respect of following facilities and infrastructure within 3 months and submit compliance on SARAS portal.

- 1. Boundary Wall: Concrete boundary wall of not less than 6 ft. height, enclosing the school campus/site.
